History: Letter found at beginning of book:

"During the moving of books for expansion of Bi-State Computor (sic) Commission, a few books were without covers and were thrown away or disposed of. Apparently books #1 and #2 of Concealed Weapons were lost at that time.

Contents: Permits pp.1-360; 16May1921 – 15Oct1924 Gives physical description of permittee including: color, age, height, weight, hair

STOLEN WATCHES

History: Paper label on ledger "Pawn Shops". Appears likely to be a registration of items at Pawnbrokers rather than a list of stolen items. One volume 1925 – 1931
